










EUROGUIDANCE SLOVENIA

Euroguidance is a European network of national resource and information centres for lifelong career guidance. Our main target group are **guidance practitioners in education and employment** and policy-makers in all European countries. Euroguidance supports the competence development of the guidance community regarding the European dimension of lifelong guidance.

Euroquidance centres share common activities that are:

- promoting European dimension in guidance and
- providing quality information on lifelong guidance and mobility for learning purposes.

Euroguidance Slovenia works within National vocational information and counselling centre (NCIPS) of Employment Service of Slovenia and is an active member of Euroguidance network since 2000. Euroguidance Slovenia is coordinating also the Career Centres of National Employment Service working on regional level.



NATIONAL COORDINATION POINT OF THE SLOVENIAN AND EUROPEAN QUALIFICATIONS FRAMEWORK (NCP SQF-EQF)

The Slovenian Qualifications Framework (SQF) represents a **unified system of qualifications in the Republic of Slovenia**. The SQF register represents an open public information system of the Slovenian qualifications framework that enables insight in all individual qualifications that are possible to be obtained in Slovenia. The task of the EQF National Coordination Point is to provide access to relevant information, to elaborate materials and to coordinate the work on how national qualifications relate to the European Qualifications Framework through national qualifications systems.

National coordination point SQF - EQF:

- takes care of the development of the SQF and its referencing to the EQF;
- provides access to information about the SQF,
 EQF and QF-EHEA on its website:
- leads the process of referencing the SQF to the EQF;

leads the process of placing supplementary

- qualifications in the SQF;publishes and maintains the register of SQF
- qualifications and connections with the EQF portal;
- issues certificates of SQF and EQF levels for NVQs.

The Institute of the Republic of Slovenia for Vocational Education and Training (CPI) was appointed the National Coordination Point (NCP) for the European Qualifications Framework (EQF) in Slovenia.


NATIONAL EUROPASS CENTER SLOVENIA

Europass is a common name for an **international system that helps to record skills and competences**. It enables to prepare professional presentations to present oneself to employment, education or other institutions. All Europass documents are free of charge and available in all European languages. Main task of National Europass Centre is promotion of Europass possibilities and bringing together stakeholders on national and international level in order to offer efficient and user – friendly solutions to the end users.

National Europass Centre offers following services:

- help and information on freely accessible Europass tools
- presentations and workshops for the groups
- maintain the system of issue of Europass Mobility documents for international learning and working experiences maintain the system of issue of Europass Certificate Supplements for education programs on the level of VET (Vocational education and training)
- informing about other services and possibilities in the field of education and training

National Europass Centre of Slovenia operates since 2005 in the framework of National Institute of Republic of Slovenia for VET (CPI).
